- Put forward that we don't want to work with Precita Eyes. Concerned that they were not aware of misrepresenting the Ohlone people and copyright laws.
- We would like to offer alternatives like Jose Castro or other local alum who are muralists.

Classified Comments

- Invite Kim to speak at the next Classified Meeting
- Would like to have someone come speak about the ASCC online course commitment
 - If we move to everything online, then we need to better support online staffing
 - Concerned that we will not be able to fill all the courses

- Identified that living far away from the college is not an equity issue
- What about staff that are in the same situation? We need to recognize that gentrification may be a factor. Additionally, some of our programs are better and draw more students
- SB 893 – What do we tell people who call into the Welcome Center? What do we tell our community?
- Equity and Antiracism Planning Council (EAPC) – this was supposed to be a work group, but it keeps being pushed back. Concerned about how it seems to be going around PBC. Also concerned about the structure of the committee because they already have tri-chairs
- On October 12th there will be a Flex Day on our Classified Contract. It is now a district wide meeting, instead of just Cañada. Additionally, we have been told that the college will be closed so all Classified will be able to attend. Do we have to show up to this or can we just zoom? The cost of gas and transportation makes it hard to attend in person.
